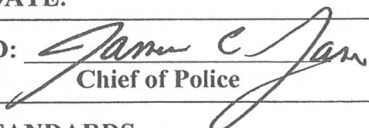

I. POLICY

The City of Norton Animal Control Officer is responsible for the enforcement of all animal-related ordinances and laws and will provide a variety of other animal-related services that do not require officer status. The Animal Control Officer will, when possible, educate the public on the importance of animal/wildlife control and safety and will assist other department members with animal-related calls for service. The Animal Control Officer will work in the Patrol Division and will be required, in times of need, to assist officers in special assignments, calls for service, and traffic accidents when the department's need for these services requires extra manpower to complete the mission. The Animal Control Officer shall treat all person(s), within their scope of authority, in a civil manner, taking any necessary action to assure good order and protection of their property and rights.

II. JOB DUTIES

Primary duties of the department's Animal Control Officer include, but are not limited to, the pickup, transportation, and impoundment of stray dogs and cats and the investigation of animal cruelty cases. The Animal Control Officer's schedule will be determined by the Patrol Division Supervisor. Other duties are, but not limited to:

1. Patrol the City of Norton and determine the most appropriate method to capture and remove animals that are endangering citizens or other animals, or causing damage to property.
2. Deal with all domesticated animals, attempt to locate the owner of problem domestic animals and determine if the animal should be housed at the animal shelter.
3. Deal with wildlife complaints and unless injured or diseased, release the animals in a safe location away from human habitation, if animal is injured or ill then the animal should be euthanized in a humane manner at a designated area.
4. Enforce local ordinances and state laws that relate to animals, issuing warnings/citations when appropriate to do so.
5. Complete all necessary paperwork when investigating animal/wildlife bite complaints and when required to do so contact the health department.
6. Investigate and conduct follow-ups on all animal complaints, including animal cruelty reports.
7. Maintain the necessary paperwork of all animals that are impounded at the animal shelter.
8. Maintain animal traps that are to be used on the properties experiencing animal nuisance problems.
9. Check all placed traps twice daily.

10. Maintain all animal-related paperwork in accordance with state laws.
11. Maintain all animal control equipment and ensure it is in proper working condition.
12. Remain current on all laws, ordinances, and procedures regarding domestic/wild animals and their welfare.
13. Complete all assigned and scheduled training.
14. Conduct other duties as required/assigned.

III. ANIMAL BITES

The Animal Control Officer will report all animal bites on the approved departmental animal bite form. As with any case report, the narrative should contain complete and accurate information. A copy of all animal bites will be maintained by the Animal Control Officer.

1. The Animal Control Officer should make every effort to identify the owner of the offending animal or, in the case of a stray or wild animal, to capture it. If owner identity can be verified and the animal has a current rabies vaccination, the owner may be allowed to have the animal confined to the required 10-day confinement of the animal. The Animal Control Officer shall explain the approved Home Confinement Agreement to the owner and obtain the owner's signature.
2. If the owner refuses to agree with the Home Confinement Agreement then the Animal Control Officer will take custody of the animal and transport it to the animal shelter for the required 10-day confinement.
3. Captured strays will be transported and confined at the animal shelter for the required 10-day confinement and the cage the animal is housed in will be marked appropriately.
4. The Animal Control Officer will contact the Wise County Health Department on all reported animal bite cases as soon as possible.

IV. IMPOUNDMENT OF ANIMALS

1. The Animal Control Officer will accept animals from citizens to be released by the owner of such said animal for the purpose of transporting the animal to the shelter. The Animal Control Officer will obtain the owner's signature of said animal prior to taking custody of the animal.
2. All Captured animals will be transported to the animal shelter in a timely manner to prevent undue strain on the animal.
3. If the animal is claimed by the owner, the Animal Control Officer will require the owner to present the appropriate tags, vaccination paperwork, and paying any required fees prior to releasing the animal back into the custody of the owner.
4. The Animal Control Officer will not seize or impound an animal determined to be located on the owner's property except if authorized by the court or unusual circumstances. This provision does not preclude the impoundment of an animal observed running at large when residents of the property are not readily available and the likelihood exists that the animal is aggressive and poses a threat to public safety.

V. INJURED ANIMALS

When on duty the Animal Control Officer will handle all cases of injured, domesticated animals and will attempt to locate the owner of such animal. In cases that the owner of the injured animal cannot be located, the Animal Control Officer will transport the animal to the local shelter. In some cases the animal may be euthanized in a humane manner.

VI. WILDLIFE COMPLAINTS

The Animal Control Officer will be required to answer all wildlife complaints.

1. The Animal Control Officer will record all wildlife complaints and attempt to trap and relocate all captured wildlife; except for deer and bear according to state code.
2. If the animal is sick or injured, the Animal Control Officer will euthanize the animal in a humane manner in a designated area.
3. All healthy animals will be released in designated areas.
4. The Animal Control Officer shall not loan out the department's traps to citizens who wish to trap wildlife.
5. The Animal Control Officer may accept and transport wildlife from citizens when the situation warrants.
6. The Animal Control Officer should, at all times, attempt to educate the public on wildlife including the elimination of the food sources to prevent the reoccurrence of the complaint.

VII. UNIFORM

The primary uniform for the Animal Control Officer will be BDU's, except for court, special events, and by the direction of the departments' administration then the uniform will be the department issued Class A uniform.

The Animal Control Officer is a sworn police officer, all other departmental policy regarding Code of Conduct and Rules and Regulations, apply as to the Patrol Division.

In the absence of the Animal Control Officer, the on-duty officers can act in his place when the situation calls for a response by the department.
