This animal transfer agreement is entered into by and between FETCH a Cure (referred to herein as "FETCH") and _____ (referred to herein as "the Shelter") as of the date _____.

Both parties acknowledge and agree to accept a transfer subject to the following conditions.

1. The Shelter agrees to place the dog in the possession and care of FETCH. The Shelter agrees to reserve space for the dog so that, as a last resort, FETCH can return the dog to the shelter anytime within three months of FETCH caring for the dog, if it is unsuccessful in the program. Once the dog is adopted the shelter forgoes responsibility of accepting the dog if the adoption is unsuccessful. A dog actively in the program can be returned up to three months, but if the dog is adopted it cannot be returned to the Shelter.
2. The Shelter will have 72 hours to make arrangements if a dog in the program must be returned.
3. FETCH's acquisition of the dog initiates the dogs entry to the program. The shelter will ensure the dog is spayed/neutered and up to date with rabies vaccinations and other applicable vaccinations. The Shelter agrees to provide FETCH with copies of all relevant records pertaining to the dog's medical and behavioral history, excluding the identities and addresses of any former owners.
4. During the dogs time with FETCH, FETCH will independently and with its own resources provide the dog with all aspects of proper care, including nutritionally adequate food, water, shelter, safe containment, veterinary care, exercise, environmental enrichment, and socialization.
5. During the dog's time with FETCH, FETCH will independently and with its own resources retain animal professionals, both Medical and behavioral, to develop a knowledgeable profile of the dog.
6. FETCH certifies that it carries the proper insurance and authorization to care for animals.
7. If the dog is determined by FETCH to be unfit for the program, the Shelter agrees to resume possession, ownership, and liability of the dog up to three months from the dog being in possession of FETCH. FETCH agrees to provide the Shelter with detailed information about the dog's tenure in the program.
8. If the dog is successful in the program, FETCH will retain possession of the dog.



9. FETCH will assume legal ownership of the dog with full right, title, and interest of the animal while the dog is in their possession. FETCH will thereby release and fully discharge the Shelter from any and all claims, actions or causes of action, which arise from or relate to the health, behavior, or conduct of the dog, while the dog is in possession by FETCH.

This animal transfer agreement is entered into by and between FETCH a Cure (referred to herein as "FETCH") and _____ (referred to herein as "the Shelter") as of the date _____.

Both parties acknowledge and agree to accept a transfer subject to the following conditions.

1. The Shelter agrees to place the dog in the possession and care of FETCH. The Shelter agrees to reserve space for the dog so that, as a last resort, FETCH can return the dog to the shelter anytime if it is unsuccessful in the program, unless the dog is a behavioral euthenasia candidate.
2. FETCH's acquisition of the dog initiates the dogs entry to the program. The shelter will ensure the dog is spayed/neutered and up to date with rabies vaccinations and other applicable vaccinations. The Shelter agrees to provide FETCH with copies of all relevant records pertaining to the dog's medical and behavioral history, excluding the identities and addresses of any former owners.
3. During the dogs time with FETCH, FETCH will independently and with its own resources provide the dog with all aspects of proper care, including nutritionally adequate food, water, shelter, safe containment, veterinary care, exercise, environmental enrichment, and socialization.
4. During the dog's time with FETCH, FETCH will independently and with its own resources retain animal professionals, both Medical and behavioral, to develop a knowledgeable profile of the dog.
5. FETCH certifies that it carries the proper insurance and authorization to care for animals.
6. If the dog is determined by FETCH to be unfit for the program, the Shelter agrees to resume possession, ownership, and liability of the dog. FETCH agrees to provide the Shelter with detailed information about the dog's tenure in the program.
7. If the dog is successful in the program, FETCH will retain possession of the dog.
8. FETCH will assume legal ownership of the dog with full right, title, and interest of the animal while the dog is in their possession. FETCH will thereby release and fully discharge the Shelter from any and all claims, actions or causes of action, which arise from or relate to the health, behavior, or conduct of the dog, while the dog is in possession by FETCH.
