Animal Intake Policy

Rakki-Inu Akita Rescue (RIAR) specifically rescues dogs that are Akita and Akita mixes. RIAR does not discriminate based on age or health of the animal, however we will not take dogs who have been evaluated as aggressive towards people. RIAR has all dogs evaluated by an Akita experienced volunteer prior to being taken into rescue, and are only placed in foster homes that are inspected and Akita experienced. RIAR will take in pregnant mothers, mothers with nursing litters, puppies, adult dogs, and seniors. If coming from a private owner, not a shelter or other rescue, we obtain an owner release form, giving RIAR full legal custody of the animal. From another rescue, we will complete an animal transfer form.

All of our fosters are microchipped, dewormed, vaccinated, and spayed/neutered upon entering rescue. They are kept on a good quality food, have regular veterinary care, are automatically tested for hypothyroidism (if 18 month or older, or are exhibiting symptoms if younger), and are kept on flea/heartworm prevention year-round.

Attached, please find copies of our Owner Release Form and our Animal Custody Record, which are filled out at time of intake and updated as necessary.
